GASCADE signs EUGAL participation agreement with three German transmission network operators

Participation of Fluxys Deutschland, Gasunie Deutschland and ONTRAS Gastransport

The transmission system operators GASCADE Gastransport GmbH, Fluxys Deutschland GmbH, Gasunie Deutschland Transport Services GmbH and ONTRAS Gastransport GmbH have signed a fractional ownership agreement for the pipeline project European Gas Pipeline Link (EUGAL).

Fluxys Deutschland, Gasunie Deutschland and ONTRAS will each receive 16.5% of the shares in the project and future pipeline. GASCADE will retain a 50.5% stake and remain in charge of the project. The partners have agreed that GASCADE will continue to manage the building process of the pipeline and will operate it in the future.

The European Gas Pipeline Link (EUGAL) will extend over a length of some 485 kilometers, running from the Baltic Sea through Mecklenburg-Western Pomerania and Brandenburg to southern Saxony and from there over the border to the Czech Republic. "The project is fully on schedule – we aim to complete EUGAL's first string as early as the end of 2019," states Chief Project Manager Ludger Hümb's.

Project executing company

GASCADE Gastransport GmbH, a joint venture between BASF and Gazprom, operates a gas pipeline network covering the whole of Germany. The network company offers its customers cutting-edge, competitive transport services over its own long-distance high-pressure pipeline network of more than 2,400 kilometers in length in the heart of Europe.

Fluxys Deutschland GmbH

The transmission system operator Fluxys Deutschland GmbH markets roughly 24% of NEL's system capacity. Fluxys also participates in the TENP pipeline system through its sister company Fluxys TENP GmbH and markets approximately 64% of TENP's transport capacities. Fluxys Deutschland is part of Belgium's Fluxys Group, which operates not only the Belgian transport system, but also a storage facility and the LNG terminal in Zeebrügge. With its numerous participating interests in existing European gas infrastructure companies and projects, the Fluxys Group pursues the goal of increasing supply security and market liquidity in Europe by simplifying international gas transport.

Gasunie Deutschland is responsible for management, operation and expansion of an extensive pipeline network in Northern Germany.
