



1. Calculation of the Capacity Charge

The payable Capacity Charge is the result of following formulas for each specific capacity.

- a) For freely allocable capacity (FZK):

$$\text{Yearly, quarterly, monthly and daily capacity: } E = K \cdot \frac{d}{d_j} \cdot s \cdot f_{uj} \cdot R$$

$$\text{Within-Day: } E = K \cdot \frac{h}{h_j} \cdot s \cdot f_{uj} \cdot R$$

- b) For firm dynamically allocable capacities (DZK) and conditional firm, freely allocable capacities (bFZK)

$$\text{Yearly, quarterly, monthly and daily capacity: } E = K \cdot \frac{d}{d_j} \cdot s \cdot f_{uj} \cdot R \cdot 0,8$$

$$\text{Within-Day: } E = K \cdot \frac{h}{h_j} \cdot s \cdot f_{uj} \cdot R \cdot 0,8$$

- c) For interruptible capacity:

$$\text{Yearly, quarterly, monthly and daily capacity: } E = K \cdot \frac{d}{d_j} \cdot s \cdot f_{uj} \cdot R \cdot f_{utb}$$

$$\text{Within-Day: } E = K \cdot \frac{h}{h_j} \cdot s \cdot f_{uj} \cdot R \cdot f_{utb}$$

4. Biogas redistribution levy

At all *network connection points* and *commercial exit zones*, as listed in the annex, an additional biogas redistribution levy of 0.8381 EUR/kWh/h/a will be added. This levy will be charged in addition to the regulated capacity tariff under Section 1 and the gas quality conversion fee under Section 5.

The short-term multipliers under Section 2 are not applicable to this levy.

5. Gas Quality Conversion Fee

At all *network connection points* and *commercial exit zones*, as listed in the annex, an additional gas quality conversion fee of 0.6711 EUR/kWh/h/a will be added. This levy will be charged in addition to the regulated capacity tariff under Section 1 and the biogas redistribution levy under Section 4.

The short-term multipliers under Section 2 are not applicable to this fee.

6. Tariff for the Alternative Nomination Procedure

The balancing group manager shall pay the following charges for the Alternative Nomination Procedure. Contractual details can be found in Section 5 of the Supplementary Terms and Conditions of Trade of ONTRAS.

- a) One-off set-up charge

7. Contractual penalty in case of harmful nomination behaviour in accordance with Section 12 No 14 General Terms and Conditions of Trade for the Entry and Exit Contract
