Capacity charges are indicated as fixed prices as € per batch.</p> <p>Prices are net.</p> <p>The weighting for forming the Merit Order List is based on the total price. The total price of the batch offered comprises the capacity charge and the product comprising commodity price, batch size and projected call frequency. Within the framework of this call for tender, the projected call frequency is 30 hours. The projected call frequency is exclusively used for forming the Merit Order List and does not represent an indication of how frequently the load flow commitment is actually called.</p>
